Detailed Conditions of Sale

- 1) The reservation will not be effective until the contract has been returned, signed, and the fee has been received by bank transfer.
- 2) The buyer, having taken into account the conditions in which inseminations take place in the approved centre, absolves the seller of all responsibility concerning his mare.
- 3) The buyer agrees to pay the centre all fees associated with livery, care, any testing required etc
- 4) The buyer declares that he knows, due to the use of artificial insemination, that the inscription of the product of this insemination in the STUD-BOOK will only be possible after the study of its hemotype and comparison with those of its parents. He agrees to bear the cost of these analyses and waives any recourse against the seller if due to these analyses there is a problem registering this product in the STUD-BOOK.
- 5) 8 straws will be sent to the buyer. If necessary, 8 more straws can be sent at a cost of only the transport and relevant health documents.
- 6) Health conditions concerning the mare :
 - a. Obligatory vaccinations against Flu and Rhino Pneumonia with the last injection less than a year ago, and a primary vaccination one month apart.
 - b. Mandatory micro-chip.
