LIVE FOAL GUARANTEE

Should the Mare fail to conceive, abort, die or not produce a **“Live Foal”**

(Live foal shall be defined as a foal that stands and nurses without assistance for a period of at least 24 hours from the time of birth) then the Stallion Owner guarantees the Mare Owner shall have the right to re-breed or substitute a mare within the current or the following breeding season only.

To qualify for the live foal guarantee a written veterinarian report must be forwarded to Al Awal Stud within **(7)** days after death of foal stating death was not caused by injury of any kind to foal, neglect of the foal, or from unsafe or unsanitary conditions.

To qualify for the Live Foal Guarantee, payment must be done at time of booking.

FEEES NOT INCLUDED IN THE NOMINATION

Each mare will be charged a non-refundable veterinary fee (which includes scanning, covering and treatments relating to the covering of the mare) of **2,000 AED**.

Each mare will be charged a boarding fee of **150 AED per day**.

CONDITIONS FOR SERVICING THE MARE

Total Nomination fee is ***Due at time of booking and is Non-refundable*** under any circumstances unless the mare or stallion die before the mare is serviced. Booking expires the calendar year of this dated contract.

Boarding and veterinary fees are due at the time of collection of the mare. All payments must come in the form of cash or a cheque. No covering certificates will be issued until payment for all services have been received.

All mares are required to be up to date on vaccinations. No mare will be accepted without proof of vaccination.

All mares require a vaginal swab and culture within fifteen (15) days prior to arrival. If the mare does not arrive with a valid culture one can be performed by us and ***billed to you at cost***, however the mare **will not** be serviced until a clean culture has been received.

Lease Mare: Lessee will provide Al Awal Stud with a copy of the passport and pedigree for the mare or any substitute mare involved in this contract, and a document showing “proof of lease”.

Al Awal Stud will *not be responsible for any accident, injury or death of mares/foals in boarding*. In the event that surgery or emergency treatment is necessary, it will be performed at the cost of the owner.

The Parties hereto understand and agree to comply with the terms and conditions as set forth in this Agreement.
